I believe your point about most of the population not giving a damn about local politics, can be traced to inadequate and difficult disclosures. We suffer this malady from a lack of public competitive political pressure. When the public has no role in policy decisions, no constituencies will develop to engage in public debate. It takes a public debate to bring policy issues into public fora. While we remain a one-party system, the public will continue to have no roll in the formation of policy. It is a vicious cycle.

The cycle will not cure itself because it is a closed system. Voters will only have a shot at gaining a voice in county policy formation if an outside group can succeed in running the tax & spend liberals back into their Democratic Party. We can only do this by closing the doors of the Republican Party to them. Once back home they can put their ideas before the public and engage Republicans in substantive public discourse on the merits of policy alternatives.

Meetings in John Dunn's airplane hangar attended by sympathetic reporters for the local fish wrap are no more relevant to the public discourse on public policy than the unchallenged palaver at an ECR Central Committee meeting. These venues stand apart and alone, without vitality; another reason why people don't care. There's no life in it - no stake for them.

Meanwhile back at the ranch, big and important issues are afoot. The front lines on what our county will become are on the northern boundary with Aurora. Aurora is very thirsty. Their water mains exist a few short feet from our border. Several of our local entrepreneurs have sold their adjudicated water rights for export to the north. The state engineer has only to say the word and water exports can begin. The county has moved to tax these water exports, however, taxes won't put water back into the aquifers. The state engineer is under legislative directives to maximize the economic value of water in the ground, so you can't blame him for allowing the transfers. People have a constitutional right to the beneficial use of their property, so you can't blame them for the transactions. Is there a balance of interests here that can maximize property owners rights, the interests of the state and county in commerce, and water conservation for the benefit of future generations? More than likely there is. Will our chance at discovering that balance be better without a public debate? Most certainly not.

This is only one reason to return the conduct of bi-partisan policy discussions to the public. The stewards of the public trust currently meeting in basements and airplane hangars aren't going to find the solutions we need.

Public policy should be squarely before the voters in the form of real elections between differentiated parties with competing ideas. Competition is a primary value that made this
